
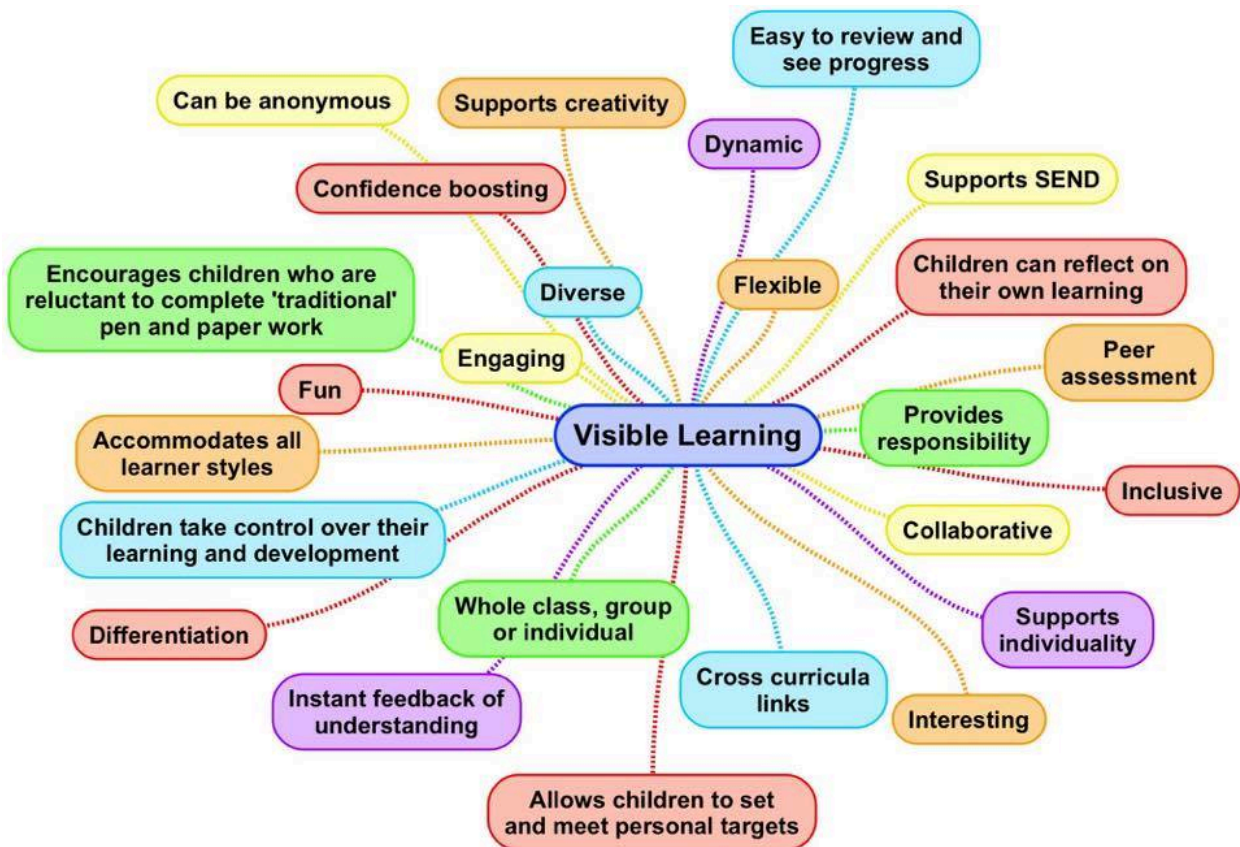

The Board of Trustees is responsible for maintenance of this scheme.

1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

CURRICULUM AIMS OF WHYBRIDGE JUNIOR SCHOOL

We believe:

- That our school curriculum should provide opportunities for all pupils to learn and to achieve
- The school curriculum should promote pupils' spiritual, moral, social and cultural development and prepare all pupils for the opportunities, responsibilities and experiences of life.

In order to achieve these aims, Whybridge Junior School provide a broad and balanced curriculum, which includes the National Curriculum as prescribed by law, based on the following principles:

- To have a curriculum which is broad enough to provide all pupils with a good general education and which will leave them well placed and qualified to go on to further stages of education.
- To have a curriculum which is flexible enough to respond to the need for change.



- To help pupils to acquire knowledge, skills and practical abilities, especially those of problem solving and decision making an effective use of language, which are relevant to adult life and employment in a rapidly changing world.
- To help pupils to appreciate human achievement in art, music, science, technology, sport and literature. To foster and celebrate excellence in human achievement.
- To help pupils understand the world in which they live and to recognise the inter-dependence of individuals, groups and nations.
- To encourage respect for religious and moral values and tolerance of others races, religions and ways of life.

This publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in the Governors Annual Report and in other Board of Trustees documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
